Minutes of the State Grievance Redressal Committee (SGRC) Meeting for People Living with HIV/AIDS (PLHAs) of the ART Centre/Link ART Centers of Arunachal Pradesh held on 8th August'2014 at Conference Hall, Directorate of Health Services, Naharlagun, Arunachal Pradesh.

The State Grievance Redressal Committee (SGRC) Meeting for People Living with HIV/AIDS (PLHAs) of the ART Centre/Link ART Centers of Arunachal Pradesh State AIDS Control Society Naharlagun was convened on 8th August'2014 under the Chairperson Ms.Indra Mallo IAS, Secretary (H&FW) cum Chairperson Arunachal Pradesh State AIDS Control Society at Conference Hall, Directorate of Health Services, Naharlagun, Arunachal Pradesh.

1. Agenda item No.1. Welcome and Introductory note.

The Secretary (H&FW) cum Chairperson APSACS welcomed all the members present and gave the introductory note.

2. Agenda Item no.2:- Action Taken Report (ART)

The Action Taken Report of minutes of last State Grievance Redressal Committee (SGRC) Meeting of 19/09/2013 was presented by the Project Director Arunachal Pradesh State AIDS Control Society and confirmed by the Committee.

3. Agenda Item no.3:-

- i. **Executive Committee (EC)** resolved that Antyodaya Anna Yojana (AAY) Card be issued to all PLHAs without photographs as special category on being certified by the Nodal Officer ART Plus Centre, Naharlagun.
- ii. **CT Scan and MRI:** Secretary Maharaj R.K.Mission Hospital Itanagar agreed for free CT scan and MRI Investigation to all PLHAS on receipt of recommendation from Nodal officer Art plus centre.
- iii. **Issue concerning PLHAS during medical treatment:** the EC strongly disapproved of the attitude of Medical staff during the treatment to PLHAS and advocated for counseling and sensitization of all medical staff of A.S.H.Naharlagun involved in care and treatment of PLHAS.EC also resolved that such act of denial & Discrimination should not recur in future.
- iv. **Adolescent Education Programme (AEP)** : AEP is being approved for West Siang,East Siang,Lohit and West Kameng Districts of Arunachal Pradesh during 2014-15.Number of Schools/ districts covered in last year & approved in current financial year to be submitted to Secretary (H&FW) cum Chairperson APSACS for approval.
- v. **To and Fro Journey expenses for PLHAS:-** The EC resolved that expenses of PLHAS for to & fro Journey to ART Plus Centre be re-imbursed from Hospital Development Fund of A.S.H.Naharlagun till Grants-in-aid to PLHAS is received from state Government.
- vi. **Social Welfare Schemes for PLHAS:** As such there is no social welfare schemes for PLHAS like widow pension at State level .APSACS has been directed to explore such schemes if any from the D.C. of concerned districts.
- vii. **Free transport passes for PLHAS:-** Director, Transport, Govt. of Arunachal Pradesh agreed that free Transport passes can be issued to PLHAS for travelling to & fro to ART Plus Centre for CD4 testing & treatment in state Transport Buses as special category.PD APSACS to coordinate with Transport department for issue of transport pass for PLHAS.
- viii. **Dressing Room for PLHAS:-** To maintain confidentiality and not to divulge the identity of PLHAS two dressing rooms could be maintained at A.S.H.Naharlagun if possible with all universal precautionary measures.

The Meeting ended with Vote of Thanks to the chair by DHS cum Vice-chairman APSACS.
