BACKGROUND

Prevention of new infections is an important area of focus in the third phase of the National AIDS Control Programme (NACP III). Targeted Interventions (TI) program for population at risk [i.e. Female Sex Workers (FSW), Men-having-Sex-with-Men (MSM), Trans-Genders (TG), Injecting Drug Users (IDU), Long Distance Truckers and Migrants] is one of the key components under NACP III. TI Program aims to provide awareness & education, commodities (such as condoms, lubes, needle & syringes) and services (such as STI treatment) for prevention and control of STI/HIV/AIDS among the high risk groups. Currently, there are 1423 TIs being implemented across the country with a human resource of around 40,000 at different levels (management, outreach, clinical, finance and administration).

Capacity building is a core element in all development programs. CB has become an integral part in the Human Resource development of all projects, which is key in providing individuals with the understanding, skills and access to information, knowledge and training that enables them to perform effectively.

It is a daunting task to train around 40,000 personnel in various thematic areas of STI/HIV/ AIDS prevention, treatment and care & support. To address these Capacity Building needs for TI service providers and considering the learnings from the earlier phases, NACP III visualized an innovative capacity building strategy different from those practiced earlier. NACP III proposed for an institutional based capacity building approach, with an ultimate aim to develop and retain a sustainable system for capacity building within each state using the state resources. In this context, the institutional mechanism of State Training and Resource Centers (STRCs) is established under the NACP-III.

Under NACP III, NACO had established 19 STRCs across the Country to effectively address the capacity building needs of the Targeted Intervention projects. These STRCs are being implemented from September 2009. This is an attempt to provide an update of the progress made by all the STRCs across the country.

Why this report?

STRCs have completed six months as on Sept 2011 in the current financial year. In order to assess the six monthly activities undertaken by the STRCs, NACO had developed a robust monitoring mechanism to assess the performance of the STRCs. This report summarizes the assessment.

This exercise is an attempt to assess the STRCs performance, understand gaps and suggest mid-way corrective measures to ensure that need based quality trainings are being imparted to TI personnel.

Who can use this report?

This report is useful for the Program Managers at NACO and SACS, Programme Officers in the TSUs and STRCs. This report can be useful in the following areas:

- a) To identify areas where STRCs need to improve.
- b) Track the course of the trainings and to prioritize the trainings based on need.
- c) Assess the progress made by the STRCs and accordingly plan future course of action.
- d) Based on the results of the grading, identify weak performing STRCs and provide hand holding support for improvement.

Scoring and Grading of STRCs

The STRCs have been graded based on their performance during April to September 2011 on the key activities entrusted and undertaken by them. These activities are: imparting training to TI personnel (as per the Annual Training Plan submitted), Conducting Training Needs Assessment, Carrying out Operational Research, Establishment of Resource Center, Developing Learning Sites and launching website. Based on the performance of the STRCs in respective activity, a score ranging between 0 – 5 is given. There are four levels of grades derived to categorize the STRCs:

A - Very Good

B – Good

C – Satisfactory

D - Poor

This categorization would help in segregating the STRCs so that the weak performing STRCs are provided more hand holding support.
